Mr. Ward moved to enter into an agreement with the Department of Environmental Protection for the Black Fly Suppression Program. The \$10,243.00 cost for spraying along the Susquehanna River will be paid through the Tourism Fund. Mr. Gerst seconded. On called vote, all voted in favor.

Mr. Gerst moved to approve an inmate housing agreement with Clinton County under which Clinton would board Montour County inmates at \$70.00 per day. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Ward moved to approve a 2015 website-hosting agreement with the County Commissioners Association of Pennsylvania at a rate of \$2,345.85. Mr. Gerst seconded. On called vote, all voted in favor.

Mr. Ward approved a Family Medical Leave Act request from Richard Hoffman, Correctional Officer, effective June 9. Mr. Gerst seconded. On called vote, all voted in favor.

Mr. Finn moved to pay the following bills: General Account, \$234,903.48; Children & Youth, \$48,472.76; Transit, \$21,903.48; Liquid Fuels, \$4,064.72; Act 78, \$4,662.46; Human and Community Service, \$887.90. Mr. Ward seconded. On called vote, all voted in favor.
