Under new business, Mr. Finn moved to approve an agreement with Northumberland County Commissioners to house Montour inmates at the Northumberland County facility at \$70.00 per day retroactive to June 4. Ms. Dressler seconded. On called vote, all voted in favor.

Ms. Dressler moved to approve an amendment to the Professional and Technical Services Agreement with SEDA-COG for the Housing Rehabilitation (Home) Program. Mr. Finn seconded. On called vote, all voted I favor.

Mr. Lynn moved to accept the resignation of Wayne Hildebrand from the Planning Commission. Ms. Dressler seconded. On called vote, all voted in favor.

Mr. Finn moved to hire Dale Myers as Veterans Affairs Director at a salary of \$26,000.00 with an additional \$1,500.00 stipend for supervisory duties effective July 15. Mr. Lynn seconded. On called vote, all voted in favor.

Mr. Lynn moved to pay the following bills: General Account, \$103,169.55; Children & Youth, \$26,501.24; Liquid Fuels, \$399.88; Human and Community Services, \$782.00; Operating Reserve, \$407.26; Other, \$19,469.16. Mr. Finn seconded. On called vote, all voted in favor.
