Mr. Finn called for public comment. Mrs. Kauwell reported 55 members of the public were served on Passport Saturday, some coming from Columbia, Northumberland and Schuylkill counties. The Board thanked Mrs. Kauwell's staff, Mary Lubeski, Sandy Drew and Jackie Woodruff, along with Deputy Bill Beitz and Danielle Parker of the Sheriff's Office and Valerie Mazol of the Register & Recorder's Office for their efforts.

Mr. Ross informed the Board that the GSVCC passed along its concerns over and support of an effort to take steps to address several dangerous intersections in Danville Borough and Montour County to the PennDOT District 3-0 Traffic Coordinator. Mr. Gaffney indicated his organization, too, is in the midst of drafting a letter of support.

Mr. Finn recessed the meeting to open a CDBG public hearing, and then turned the hearing over to Mr. Lowthert, who reported the County is expected to receive a 2012 allocation of \$211,523.00, which is a 3.9% decrease over current funding. Mr. Lowthert outlined project proposals as following: Derry Township, Crawford Road Bridge and Roadway Reconstruction, \$200,000.00; Cooper Township Municipal Authority, Sewer and Water Line Extension, \$178,000.00. Mr. Lowthert noted two applications from Anthony Township have since been withdrawn. Mrs. Gill presented an application on behalf of Sunnybrook Park Association for a handicapped chair lift for the swimming pool with a funding request of approximately \$7,400.00.

The Board agreed to an accelerated application schedule due to deadline changes from the Department of Community and Economic Development. Under the new schedule, projects will be approved at the Board's April 10 meeting.

Under old business, Mr. Gerst moved to approve a resolution designating EMA Director Walt Peters as the agent to execute documents under the Hazard Mitigation Grant Program for a property buyout application related to September flooding. Mr. Ward seconded. On called vote, all voted in favor.

Under new business, Mr. Gerst moved to accept the resignation of Ronald Stevens as Correctional Officer effective February 28. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Gerst moved to approve the hiring of Dennis Hendricks as Correctional Officer at an hourly rate of \$11.39 with a tentative start date of March 26. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Gerst move to approve the following purchase of service agreements on behalf of Children & Youth Services: Families United, Ashler Manor, Adelphoi, Family Care for Children & Youth. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Gerst announced two upcoming fundraisers to benefit the Danville Challenger League: Sumo Wrestling at 6 p.m. April 20 at the Danville High School and a pig roast/auction at 3 p.m. June 30 at Southside Fire Co.

Mr. Gerst moved to pay the following bills: General Account, \$178,174.54; Children & Youth, \$27,392.43; Transit, \$13,819.82; Liquid Fuels, \$88,080.75; Act 78, \$5,944.12; Domestic Relations, \$8,208.59; Human and Community Service, \$842.32. Mr. Ward seconded. On called vote, all voted in favor.

There being no further business, the meeting was adjourned.
