Mr. Holdren asked those so inclined to rise for a prayer led by Pastor Molter. The Pledge of Allegiance was recited in unison. The meeting was then opened.

Mr. Finn moved to approve the minutes of the previous meeting. Mr. Holdren seconded. On called vote, all voted in favor.

Mr. Finn moved to accept the Treasurer's report as presented. Mr. Holdren seconded. On called vote, all voted in favor.

Mr. Holdren called for public comment. There was none.

Mr. Holdren moved to adopt a resolution proclaiming March 12 - 18 as Pennsylvania 4-H Week in Montour County. Mr. Finn seconded. On called vote, all voted in favor. Mr. Holdren noted the 4-H program is "alive and well and strong" in Montour County and commended staff and volunteers for their work.

Elaina Tyson and Damian Brown were recognized for achieving the 4-H Diamond Status Clover Award, which is the highest honor in the 4-H program, similar to an Eagle Scout or Gold Award in Scouting. Ms. Tyson told the Board she completed a Treats for Troops project, sending 100 care packages to service members stationed abroad. She remarked on the importance of letting troops know that they are remembered because not every service member has family back home to do so.

Mr. Brown said he designed, constructed and raised funds for a 4-H storage room at the Montour-DeLong Fairgrounds.

There was no old business.

Under new business, Mr. Holdren moved to approve drafting a letter of support for the Danville Area Community Center's efforts to secure funding through the Community Project Funding Grant for a renovation project. Mr. Finn seconded, noting the DACC is looking to expand before- and after-care services. On called vote, all voted in favor.

Mr. Finn moved to affirm the promotion of Tara Zeidler to Deputy Chief Adult Probation/Juvenile Probation at a salary of \$45,278.00 effective March 13. Mr. Holdren seconded. On called vote, all voted in favor.

Mr. Holdren moved to appoint Joseph Stigerwalt as Acting Maintenance Supervisor effective February 1 with a corresponding 5% wage increase. Mr. Finn seconded. On called vote, all voted in favor.

Mr. Holdren moved to pay the following bills: General Account, \$180,582.57; Children & Youth, \$34,548.77; Liquid Fuels, \$354.10; Human & Community, \$1,089.44; Other Funds, \$43,958.98. Mr. Finn seconded. On called vote, all voted in favor.

There being no further business, the meeting was adjourned.
