Mr. Gerst moved to approve the minutes of the previous meeting. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Ward moved to accept the Treasurer's report as presented. Mr. Gerst seconded. On called vote, all voted in favor.

Under old business, Mr. Ward moved to advertise for bids for the parking lot project at the Gateway property, Transit and 911 Center. Mr. Gerst seconded. On called vote, all voted in favor.

Under new business, Mr. Gerst moved to approve submission of a \$40,000.00 Keystone Recreation Grant application on behalf of the Thomas Beaver Free Library. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Gerst moved to approve purchase of service agreements on behalf of Children & Youth Services with Hempfield Behavioral Health Inc., Harrisburg, and Adelphoi USA, Lewisburg. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Ward approved unpaid medical leave for part-time Transit employee Lee Woodside effective January 30. Mr. Gerst seconded. On called vote, all voted in favor.

The Board acknowledged a letter of resignation from James Loy, Limestone Township Constable, effective February 16.

Mr. Gerst authorized the Chief Clerk to advertise for the position of Veterans Affairs Director. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Ward moved to request that Chairman Finn appoint Herbert Zeager as chair of the Agland Preservation Board. Mr. Gerst seconded. On called vote, all voted in favor.

Mr. Gerst moved to approve a resolution honoring Lt. Col. Alan Buck on his retirement after 26 years in the Air Force. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Finn then read the resolution aloud and presented it to Lt. Col. Buck. Mr. Kelley presented a citation to Lt. Col. Buck from state Rep. Bob Belfanti as did Ms. Mathias on behalf of Congressman Chris Carney. Ms. Dragano read the lyrics of "That Old Ragged Flag" in honor of Lt. Col. Buck.

Lt. Col. Buck thanked those in attendance for their efforts, noting that when someone retires from the military those people usually ask for an American flag to be flown over the state or nation's Capital. He said he felt it would be more meaningful to have the flag flown over the courthouse in his hometown. Lt. Col. Buck said he was overwhelmed by the show of support.

Mr. Ward moved to pay the following bills General Account, \$192,171.368; Children & Youth, \$39,587.88; Transit, \$14,722.86; Liquid Fuels, \$632.47; Act 78, \$15,640.23; Domestic Relations, \$9,751.59; Human & Community, \$3,778.55. Mr. Gerst seconded. On called vote, all voted in favor.

There being no further business, the meeting was adjourned to raise American, state and POW flags outside of the courthouse in honor of Lt. Col. Buck. The flags will be presented to him at his mustering out ceremony later this year in Colorado.
