Under new business, Mr. Gerst moved to let bids for three accessible mini-vans, with the option to purchase two more, for Transit with bids due by 3:00 p.m. March 23. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Ward moved to enter into a contract with Signing And Signal System Installers, Mifflinville, for service to the County's traffic signal. Mr. Gerst seconded. On called vote, all voted in favor.

Mr. Gerst moved to affirm the hiring of William Forbes as Tipstaff at an annual salary of \$5,194.24 effective February 17. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Gerst moved to reappoint Raymond Vella, to a three-year term on the CMSU Developmental Supports and Services Advisory Board, through June 30, 2012. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Ward moved to pay the following bills General Account, \$125,434.20; Children & Youth, \$26,766.76; Transit, \$2,209.19; Liquid Fuels, \$448.75; Act 78, \$2,316.99; Domestic Relations, \$1,264.62; Human and Community, \$0. Mr. Gerst seconded. On called vote, all voted in favor.
