Mr. Ward moved to approve a maintenance agreement with Susquehanna Fire Equipment Co., pending verification of an Amerex fire extinguisher listed for Transit on the agreement. Mr. Gerst seconded. On called vote, all voted in favor.

Mr. Gerst recognized Danville Borough Councilwoman BettyAnn Moyer who was featured in an edition of the publication "Borough News" for speaking to the House Local Government Committee against proposed legislation that would consolidate all municipal governments in the Commonwealth under counties.
