Mr. Bunch expressed concern that the land is exempt from real estate taxes, this putting the tax burden on homeowners. Commissioners said they were unaware of any such sales in Montour County, but would look into the matter.

Brian Crane, The Learning Tree, Alternative Rehabilitation Communities Inc., Law Offices of Marks, McLaughlin and Dennehy, George Junior Republic, Cornell Abraxas Group Inc. Mr. Finn seconded. On called vote, all voted in favor.

Mr. Finn moved to approve submission of the 2016-17 Adult Probation Grant-in-Aid application to the state Board of Probation and Parole in the amount of \$79,949.00. Mr. Hartman seconded. On called vote, all voted in favor

Mr. Hartman moved to affirm a letter of retirement from Prison Warden Gerald Cutchall effective close of business July 29. In making the motion, Mr. Hartman thanked Warden Cutchall for his exemplary service to the County, which spanned nearly 27 years. Mr. Finn seconded. On called vote, all voted in favor.

Mr. Finn moved to approve the hirings of James Hagenbuch and Sean Versluis as parttime Correctional Officers effective July 12. Hartman seconded. On called vote, all voted in favor.

Mr. Hartman moved to pay the following bills: General Account, \$159,852.54; Children & Youth, \$16,312.16; Transit, \$7,224.87; Liquid Fuels, \$72.17; Uniform 911, \$10,437; Human and Community Service, \$1,311.27. Mr. Finn seconded. On called vote, all voted in favor.
