Mr. Hartman moved to approve the minutes of the previous meeting. Mr. Finn seconded. On called vote, all voted in favor.

Mr. Finn moved to accept the Treasurer's report as presented. Mr. Hartman seconded. On called vote, all voted in favor.

Mr. Holdren called for public comment. There was none.

Under old business, Mr. Finn moved to reject all bids for an Air Quality HVAC System at the Prison. Mr. Hartman seconded. Mr. Finn said the County did not provide enough detail in the bid request and have engaged an engineer to draw up a proposal to re-bid. On called vote, all voted in favor.

Mr. Hartman moved to approve a 2022 web hosting/maintenance renewal with Tyler Technologies for the Assessment Office at a cost of \$10,785.00. Mr. Finn seconded. On called vote, all voted in favor.

Mr. Finn moved to approve a PCorp Loss Prevention Grant Application of \$889.00 to purchase a window air conditioner for the Food Pantry to reduce the temperature per state guidelines. He noted this is unrelated to an air quality issue in the Administration Center which is being handled separately. Mr. Hartman seconded. On called vote, all voted in favor.

Mr. Finn moved to approve a PCorp Loss Prevention Grant Application of \$1,280.00 to purchase a rear camera for the Maintenance Office skid loader. Mr. Hartman seconded. On called vote, all voted in favor.

Mr. Holdren moved to approve the Adult Probation Grant-In-Aid application to the Pennsylvania Commission on Crime and Delinquency for fiscal year 2021-22 in the amount of \$15,388.00. Mr. Finn seconded. On called vote, all voted in favor.

Mr. Hartman moved to pay the following bills: General Account, \$162,296.23; Children & Youth, \$61,284.01; Uniform 911, \$0; Human and Community Service, \$846.15; Liquid Fuels, \$386.54; Hazard Mitigation Grant Program, \$711.30; Operating Reserve, \$14,225.79; Other Funds, \$238,713.98. Mr. Finn seconded. On called vote, all voted in favor.

There being no further business, the meeting was adjourned.
