Mr. Finn moved to make a donation of \$1,000.00 from the County's Hotel Tax administrative fee fund to the Danville Halloween Parade. Mr. Hartman seconded. On called vote, all voted in favor.

Mr. Finn moved to appoint Leslie Young to a vacancy on the ECEN Advisory Board. Mr. Hartman seconded. On called vote, all voted in favor.

Mr. Finn moved to accept the resignation of Jeremiah Rockwell, Correctional Officer, effective September 27. Mr. Hartman seconded. On called vote, all voted in favor.

Mr. Finn moved to pay the following bills: General Account, \$246,380.61; Children & Youth, \$60,771.68; Human and Community Service, \$947.95; Liquid Fuels, \$6,226.64; Operating Reserve, \$10,481.40; Other Funds, \$13,110.18. Mr. Hartman seconded. On called vote, all voted in favor.
