Under new business, Mr. Finn introduced Ms. Wakeman, who provided information on the RiverStage Community Theatre and its upcoming production of "Gypsy" July 7 through 12 at the Danville Middle School. The group has been staging three productions annually for a number of years in communities throughout the region, drawing audiences from as far away as Williamsport. In addition to offering a creative outlet for those involved in the productions, community theater can have a positive economic impact on small communities by way of tourism, Ms. Wakeman said, noting the summer musical traditionally brings 600 visitors into the community. In addition to "Gypsy," the group is planning another show next year at the Danville Middle School and is also looking at performances at the Jane E. DeLong Community Hall in Washingtonville.

The theater group is registered as non-profit and its members are volunteers, said Ms. Wakeman, which is why RiverStage seeks funding through business and community leaders. Mr. Finn said the theater group provides a way to bring cultural opportunities here that isn't normally offered, and moved to approve an allocation to the organization of \$1,000.00 from Tourism Fund monies through the ColumbiaMontour Visitors. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Ward moved to approve a proposal of \$5,219.00 from Window World to replace windows damaged by the hail storm on May 22. Mr. Gerst seconded. On called vote, all voted in favor.

Mr. Gerst moved to approve the hiring of Robert Baylor as a Part-Time Correctional Officer at an hourly rate of \$11.27 effective July 25. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Gerst moved to approve the hiring of Bradley Hertzog as a Part-Time Correctional Officer at an hourly rate of \$11.27 effective July 15. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Finn announced the annual National Night Out activity in Montour County will be held Tuesday, August 5, at Washies Playground. Law enforcement and emergency services providers will offer activities, free food and drinks and giveaways from 5 to 7:30 p.m.
