If you are unable to return your voted mail-in/absentee ballot by the deadline, you may only vote a provisional ballot at your polling place on election day, unless you surrender your mail-in/absentee ballot and the return envelope containing the Voter's Declaration to the judge of elections to be voided to vote by regular ballot.
