Mr. Gerst moved to approve a PEMA Radiation Emergency Response Fund grant agreement in the amount of \$1,800.00. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Gerst moved to approve the hiring of Tara Fahey as a call-in Transit Driver effective May 24 at an hour rate of \$8.00. Mr. Ward seconded. On called vote, all voted in favor.

Mr. Gerst announced a Ride for Shelter fund-raiser to benefit the Women's Center on July 24.

Mr. Gerst commented on the success of the annual Fish Derby, giving special recognition to Jack Lee for all his work.
