HUMAN SERVICES NARRATIVE

EMERGENCY RENTAL ASSISTANCE PROGRAM

At least 90% of the awarded funds received by Montour County Human Services will be used by *Central Susquehanna Opportunities Inc (CSO)* to provide direct financial assistance to eligible households, including the payment of rent, rental arrears, utilities and home energy costs, utilities and home energy costs arrears, and other expenses related to housing incurred due, directly or indirectly, to the novel coronavirus disease (COVID-19) outbreak.

Central Susquehanna Opportunities Inc (CSO) will determine eligibility for Emergency Rental Assistance in accordance with the federal and state eligibility requirements and as outlined in the Instructions and Requirements document that DHS has provided. Assistance is available for households: (1) with an obligation to pay rent on a residential dwelling or utility and home energy obligations; (2) with one or more members who qualified for unemployment benefits, experienced a reduction in household income, incurred significant costs, or experienced other financial hardship due, directly or indirectly, to COVID-19; (3) with one or more members who demonstrate a risk of experiencing homelessness or housing instability; and (4) with an annual or monthly household income up to 80% of the Area Median Income (AMI) for the household.

- Emergency rental assistance will be offered to eligible individuals and households within the county who are obligated to pay rent on a residential dwelling and the household has qualified for unemployment benefits or experienced a reduction in household income or other financial hardship due, directly or indirectly, to COVID-19, has demonstrated a risk of experiencing homelessness or housing instability and has a household income that is not more than 80% of the Area Median Income.
- Emergency utility and home energy assistance to be offered to individuals and households within the county who have utility and home energy obligations, including electricity, gas, water/sewer, trash removal and heating and the household has qualified for unemployment benefits or experienced a reduction in household income or other financial hardship due, directly or indirectly, to COVID-19, has demonstrated a risk of experiencing homelessness or housing instability and has a household income that is not more than 80% of the Area Median Income.
- Other emergency financial assistance may be offered to eligible individuals and households for other expenses related to housing, incurred due, directly or indirectly, to the novel coronavirus disease (COVID-19) outbreak.

Housing Stability Services and Administrative Costs:

Not more than 9.09% (\$108,988.43) of funds received by Montour County will be used for housing stability services, including case management, other services to keep families stably housed and administrative costs. Not more than 5% (\$59,949.63) of this amount will be used for Administrative costs.

Housing stability services to be offered to eligible individuals and households at risk of or experiencing homelessness, may include hotel/motel stays, boarding homes, and similar services to provide shelter as needed. Case management will be provided to each household to ensure stability has been achieved.

Administrative cost may include purchase of hardware, software, and materials needed to operate the program, as well as hiring of personal to provide service to county clienteles.

Central Susquehanna Opportunities Inc (CSO) will administer 4.09% for Housing Stability and 4% Administration. Montour County Human Services will utilize 1% for Administration.

COMPASS Community Partner/Record Retainment:

Central Susquehanna Opportunities Inc (CSO) and Montour County Human Services are registered as COMPASS community partners. Eligibility records and other records necessary to support the expenditure reports submitted to the Department of Human Services will be maintained for five years.
